1. Vendors must provide their own equipment ie: canopies, tables, chairs etc. Vendors with tent spaces MUST bring tent weights.
2. REGISTRATION: Vendor Forms must be submitted by 05/15/26, along with 5-6 photos of what you'd like to sell. If you have a website or social media page dedicated to your business, please include a link/name. Space is limited. Vendors who submit first will receive first consideration. Your payment will be due once final decisions have been made on which vendors will be in the market. All fees are non-refundable as they are used to promote the event.
3. No electricity or running water is available.
4. Restroom access inside K&K Bar-b-cue.
5. Market will run from 9am - 3pm.
6. Set up Time: Vendors may not begin setting up before 7:30 am and must be finished by 9am. Break down may not begin before 3pm, and must be completed by 4pm.
7. Each vendor will have a designated spot, decided by the event organizer.
8. Vendors are responsible for leaving the area in the same condition as they found it.
9. We reserve the right to censor any booth. The Patio/Purdon Groves representatives will have final approval of vendor participation and reserve the right to reject any application.
10. Vendors agree to abide by on-site instructions given by The Patio/Purdon Groves, its employees or representatives. Failure to do so may result in being asked to vacate the market immediately.
11. Our goal is for this to be a family-friendly event. All merchandise must follow normal social appropriateness. Any items deemed inappropriate will be required to be removed immediately.
12. A vendor may park their personal vehicle behind the building or in one of the parking spots on Beaton directly in front of The Patio, for load in and load out ONLY. Vehicle must then be moved to a side street to allow for parking for customers.
13. If a vendor needs to leave early, they will need to hand-carry or cart out their items.
14. Vendors are required to know the laws, rules and regulations of their business. All health and food safety regulations are to be followed. Please check with the Navarro County Health Department (903.874.6731) for further information.

15. If, due to unforeseen circumstances, The Patio Vendor Market must be canceled, the reservation fee will be transferred to another month. No refunds will be given.
16. No smoking or vaping is allowed in The Patio Vendor Market area.
17. Profanity, foul language or behavior that is less than family-friendly will not be tolerated.
